As I am a Nevada resident and leaving to our new home in Aliante and whereas the fourth degree (13 criminal) criminal charges were dismissed as the NEW outstanding First Assistant Prosecutor Gregg Mueller took over these cases and on his first day my bail was exonerated and cases dismissed thereafter and whereas the corrupt Judge Dana's illegal sentence where I was imprisoned falsely in Keogh Dwyer Correctional facility for 85 days as witness were not allowed to testify in my defense, perjury was committed as obvious on the court transcript, whereas Judge Dana refused to provide me a copy of the transcript costing me

\$5,000 which convicts dozens as some committed perjury and others in essence admitted their criminal acts which included kidnapping me from an OPEN PUBLIC Meeting at its designated location with breach of duty, outrageous conduct as while wearing a suit and just walking into the Town Council meeting I was assaulted and pushed out of the town council meeting as I had not even said a word and was finger printed one of the many dozens of times and whereas I have asthma and hypertension and required as my wife looked on in great pain as she has very painful fibromyalgia I had to be taken by ambulance to the emergency room handcuffed.

This travesty is so obvious its sickening.

1. Read the transcript that was part of the indictment by the corrupt Sussex County Prosecutor David Weaver and his corrupt A.P. Joseph Corazza. It is the transcript of the corruption in Morris County Superior Court among the felons Judge Bozonelis, AJSC and Richard Stein, the corrupt constant perjury and deceiver for years who in a public town council meeting noted on my web site ThomasCaggiano.com and now renamed FreedomNewsDigest.com from Nevada shows there was complete complicity, confederation with the NJ Attorney General, the Government Record Council, the law firms in Frankford Township as my speeding ticket appeal before Judge Conforti which was transferred to Frankford Township and those transcripts show how corrupt Judge Devine, and others are.

Judge Bozonelis admitted he had NO evidence that I submitted eight hundred Open Public Record Act requests ALL on Zoning as Richard Stein just lied and lied and lied. The GRC's own print out of GRC 2006-02 which took 3 years as Ms Robin Kline the excellent former Town Municipal Clerk for Stanhope did what a person should do REPORT crimes for if one does NOT it is a felony NJDA 2C:2-1 so she reported them for over a year to at least 10 organizations as a private citizen and was targeted by Stanhope and threatened by the corrupt former Town administrator Teri Massood who fled Stanhope without resigning when GRC 2006-02 was given to the corrupt Office of Administrative Law Judge J. Howard Solomon, ALJ as Teri Massood admitted she willfully destroyed govt records and the former corrupt Municipal clerk Battaglia admitted she refused to give any copy of anything related to the illegally developed Block 10902 Lot 10 and 12 minor subdivision.

Judge Bozonelis to prevent me from exposing more corruption in Stanhope for decades as NO contracts existed at all in 2006 that complied with

the Local Public Contracts Law for any paid professional engineer or planner appearing before the public as fraud was the constant effort by the Mayor Diana Kuncken, Laddey, Clark and Ryan LLC, Dolan and Dolan PA, and their corrupt lawyers Richard Stein, Roger Thomas, John Leo III as Omland Engineering Associates and its corrupt VP and PE portrayed themselves as the Borough Engineer Eric Keller, PE/PP and did Not even show up at Land Use Board meetings as the corrupt John Cilo Jr. and his corrupt paid Town Planner Scarlet Doyle did NOT have any contract for over a decade as the Land Use Board and its Planning Board were infested. The corrupt Construction Code Official Thomas Pershouse can't see a deck is built on the wrong side of the rear of the deck on 6 Oak Drive with staircase in wrong direction and wrong side of house, that shade trees plotted to be saved were destroyed, that every property owner wrote letters surrounding the development for years. The people screamed at the corrupt felons. Their letters were read by me to the corrupt State Sussex County Soil Conservation District's corrupt Chairman Clifford Lundin, Esq. former Mayor of Hopatcong and his other "dignified felons" serving on Sussex County Planning Board or Sussex County Board of Chosen Freeholders which has the false plans since Nov 5, 2008 as you can listen on the wifi to my 10 minute presentation.

READ the transcript in the indictment and file a Affidavit of Probable cause as I did in Morristown municipal court and Green and Newton and you GET NO hearing as the corrupt judges just either dismiss them in Superior court where they should NOT even be like Conforti or just bury the CDR-1 summons which should obviously be a CDR-2 an arrest warrant as the charges are first degree crimes NJSA 2C:30-6.a violation of civil rights with bodily harm.

Manahan corrupt presiding judge Kathy Caggiano who was never charged with anything except threatened by Dana on the record as he told her to get a lawyer which terrorized her. Banned her and myself from even signing a CDR in any municipal court in Sussex County or Morris county for any reason as the other public are just terrorized to report criminal conduct as the tyranny has shown what happens when a citizen re-

ports official criminal acts. they get jailed, have their red blood cells reduced 50 percent by being involuntarily placed in a mental institution for 18 days by the corrupt felons in Hopatcong as Lundin was its prior mayor and its corrupt judge and prosecutor don't allow witnesses who sign letters to even testify and convict you at 12:20 a.m. that past midnight.

What case runs that long? One that have corrupt judges like Browkley JR and his corrupt prosecutor Arbone screaming jail him, jail him as I sent emails reporting the corruption at paramount self storage and E.N.F. Development projects. Just get those files from SH#44 box in Sussex County Soil Conservation District as its State hired PE Sedivy is an obvious felon protected by the corrupt Office of the Attorney General's Department of Consumer Affairs and its corrupt Board of Engineers and Board of Professional Planners.
