Department of Community Affairs corrupt Government Record Council and inform the corrupt Superior Court Judge Sypke that the corrupt court order brought by the former corrupt NJ Attorney General Anne Milgram, Esq., the corrupt Div of Law Debra Allen, Esq. with the corrupt lawyers from the GRC its executive director Catherine Starghill, Esq. and In-house lawyer Karyn Gordon violates the Open Public Meeting Act in that per the Appellate court decision overriding the Superior Court and the GRC a person is allowed to send in an OPRA request by email to the corrupt GRC itself.=====I hope you hire lawyers that have read C.E.P.A., know that the Rules of Ethics and so called Rules of Professional Conduct apply to them and fire and arrest the corrupt Sussex County Prosecutor David Weaver. Please see the Mercer County Prosecutor and ask him why he has NOT filed Open Public Meetings Act violations for civil fines against the corrupt Department of Community Affairs' and its GRC for NOT sending me copies of its agendas 48 hours in advance and get a new Department of Treasury's Office of Administrative Law Chief and its Judges as the six executive judges I met were felons. Also ask the Acting Attorney General Paula Dow as Essex County Prosecutor how come her staff in the Newark State Essex County Prosecutor's office threw me out of its offices, don't know that Superior Court Judges go by Vicinage NOT county and never heard of District Ethics Committees. One would think some State employees working in the Essex County Newark municipal court for the Essex County Prosecutor would realize that if Mayor Sharpe James committed and was convicted of Federal Felonies why were NO State criminal charges ever filed against him or any of his conspirators and accomplices? Why do NOT any State County Prosecutor ever file any State criminal charge against any official already in federal prison for obviously they and other conspirators committed State Criminal Act such as Official misconduct NJSA2C:30-2.b, the felony of omission NJSA2C:2-1 and what about the crime of

complicity for the corrupt Trenton municipal court prosecutor who is guilty of that crime himself told me their is no such crime. In Trenton's corrupt municipal court they won't even give you a copy of the CDR you yourself signed and of course its corrupt Municipal Judge Sancinito and his corrupt court won't even give me a copy of the transcript of my trial as the Trenton Superior Court Judge has my appeal. It would be very nice if your Division of Criminal Justice didn't have such corrupt State County Prosecutors such as David Weaver that indict you for reporting criminal conduct! finned me thousands of dollars, had me illegally jailed for 85 days illegally in the corrupt Keogh Dwyer Correctional Facility, not responded to many dozens of OPRA requests, not provided me medical records and records I provided the corrupt Anne Klein Forsenic Center despite letters to its corrupt Commissioner, the supervisor of the corrupt Dr. C. Joseph and corrupt Dr. Peter Paul who both wrote false mental evaluation reports which conflict with one another and other mental evaluations I paid thousands to defend myself against now being declared by the corrupt State of New Jersey's Superior Court of the felon the dishonorable N. Peter Conforti, JSC who stated on the court record he would refuse to read or hear any evidence by a voluntarily hired psychologist or psychiatrist that disagree with the medical report he demanded I take as I was already in Jail by the corrupt Judge Craig U. Dana, JMC on his illegal and unconstitutional own kangaroo court convictions on 13 petty disorders brought against me by the felons in the Borough of Stanhope ALL of which were transferred to the quaint town of Tranquility where crime fosters in an imbred system of corruption in New Jersey Courts and its corrupt executive branches which continue.

===== Ann Rosllen the corrupt municipal court administrator in Newton's infested town and center of corruption in the pandemicly corrupt Sussex County in her letter informs me that the reason she did NOT comply with municipal court rules on processing complaints, summons and arrest CDR-1, CDR-2 and enter docket numbers of the quasi-criminal and other many criminal charges I filed was because the Vicinage Presiding Judge the corrupt Thomas Manahan issued on the criminal indictment against me on 13 other CRIMINAL Charges and a false petty disorder charge by the corrupt chief of police of Stanhope that I refused to be fingerprinted for the 20th time in his corrupt municipal court building infested with the lowest of lows in the perjury of its Mayor Diana Kuncken and its lowest of them all the perjurer of Laddey, Clark and Ryan LLC best of best felons Richard A. Stein, Esq. who has for years committed perjury so many times I lost count but it of course was in the original Statement of Information on 18 Separate actions noted on the corrupt Department of Community Affairs web site at the corrupt organization whose charter must be DO NOT allow release of any govt document as its corrupt Chair Tabakin or whatever her name is with its Commissioners of Community Affairs starting with ex-Gov Corzine's campaign manager Susan Bass Levin, Richardman and the felon Joseph Doria as former NJ State Senator, NJ Assemblyman and Mayor was buried in over 15,000 pages of evidence in his corrupt departments such as its Ethics Committee, GRC, Office of Smart Growth, Codes and Stds, Local Govt Services that the corrupt GRC with the former ex-NJ Attorney General Ann Milgram the successor to the corrupt counsel for Senator Corzine, as counsel to the corrupt Gov Corzine, as Attorney General of NJ for the corrupt Gov Corzine and is now NJ corrupt Chief of NJ Supreme Court nominated by the corrupt ex-Gov Corzine and approved by the NJ Senate as its Senators have thousands of pages of evidence of his corruption as did the ex-Speaker of the General Assembly Roberts as the new Speaker has been provided evidence to impeach this lesser of NJ corrupt Court system. Just visit her State Commission of Investigation's executive director and its staff member Ms Gore who herself visited my home at 10 East Drive, Stanhope, NJ which I can't sell as the corrupt municipal clerk Ellen Horak is intercepting my mail which I reported to the FBI in Las Vegas and per their direction have reported her criminal conduct to the USPS National Law Enforcement Control Center and have begun an investigation as I'll be meeting with the U.S.P.S. investigators within two weeks. ===== The municipal court administrators in Newton, Morristown, Stanhope, Newark N.J. won't even enter complaints in the Judicial court docket system per rules of NJ municipal court process R 7:2. The excuse given by Rosellen is that the corrupt Presiding Judge Manahan wrote a court order on his own initiative without any hearing to

ban my wife Kathryn Caggiano or myself from allowing any municipal court clerk in any municipality in MORRIS County or Sussex County to enter a docket on any petty disorder or criminal Affidavit that was filed by her or myself against any person, any law firm or any thing for anything without a Superior court judge reviewing them? Well that was four months ago. ===== There never has been any hearing by any municipal court judge if needed per NJ court rules on dozens of Affidavits I file under oath called complaints in Newark where Mr. Jackson of Newark's municipal court would NOT even give me a blank complaint form as I sat at the complaint window in Green St's municipal courthouse where the felon Mayor Sharpe James was never even charged with any State crime as he took a \$9,000 cruise AFTER he finally left office on a police credit card and was then imprisoned in a federal jail for giving away essentially or flipping Newark land with the aide of those in his municipality to his girl friend. Not a single State criminal charge was made by Essex State County Prosecutor Paula Dow who is now NJ Acting Attorney General under Gov Chris Christie. Of course Chris Christie was NJ's U.S. Attorney in Newark a few blocks from the Newark municipal court and never found it strange that over 100 felons were placed in Jail on corruption and bribery especially from Hudson County but NOT one State criminal charge was ever filed for conspiracy as one would think it took at least two people to take these many criminal actions. ===== So the reason there are no State criminal charges as I have found out in my seven year case study of Tyranny in Gov is if you file a criminal charge or report a criminal charge or ethics charge you are convicted dozens of times, declared mentally incompetent without a mandatory hearing, jailed for 3 months, have your red blood cells reduced 505 by drugs forced into your system after being involuntarily placed into a mental institution while drugged unconscious after being placed in a five point restraint system and not even give a telephone to call your wife or one of NJ corrupt lawyers. ===== Well how does Ann Rosellen explain she did NOT enter the CDRs that I filed in her court into dockets CDR-2 before the corrupt Judge Manahan issued his obvious corrupt court order on Ind 08-09-316 in State of NJ v. Thomas Caggiano against my wife? Why didn't she enter the one's I submitted prior the corrupt Judge's order? The corrupt N. Peter Conforti, JSC dismissed the criminal charges. So the restrictions by the corrupt Judge Manahan were also dismissed but NOT per Ann Rosellen as she still refuses to enter a single CDR-2 for the dozens of Affidavits of Probable Cause she and her deputy court administrator. Of course the corrupt William Hinkes law firm is the Borough Attorney of that corrupt Newton municipality where the central hub of criminality is as the corrupt State Department of Agriculture's cease pool Sussex County Soil Conservation District is located and just look at the 2,700 pages of evidence in application file box SH#44 regarding the illegally developed minor subdivision in Stanhope the gateway to the corrupt Sussex County by E.N.F.
