1. Please accept this email as a brief for a change of Magistrate and Change of Venue for the above municipal appeals

2. As noted in R 3:10-2(d) on motions to the municipal court and in the Superior Courts own findings that I was illegally sentenced, illegally re-sentenced and illegally re-re-sentenced by the corrupt Judge Dana, JMC on Sep 10, 2009 and many other motions were willfully ignored by Judge Dana who did not allow witness who were in the court room to testify in my defense, allowed perjury proven by the transcript records wherein Laddey, Clark and Ryan LLC Borough Attorney Richard A. Stein, Esq falsely under oath testified that the Borough has provided me copies of all documents I requested and before Judge Bozonelis he falsely stated I made eight hundred Open Public Record Act requests ALL on Zoning as in the transcript record provided me under discovery from the Sussex County Prosecutor David Weaver who has NOT acted in good faith and has constantly violated the Rules of Professional Conduct, has not responded to interrogatories, whereas the Borough of Stanhope has willfully ignored your court orders and also that of Judge Bozonelis and in Trenton municipal court in State of New Jersey the Borough of Stanhope officials without any letter to quash valid supbeano refused to appear as witness and as stated on the court record of the Office of Administrative Law before Judge J. Howard Solomon, ALJ the former Town Administrator Teri Massood fled the Borough of Stanhope without any letter of resignation or severence pay per Chap 2.2 Administration when the GRC filed 2006-02 with the Office of Administrative Law and the former OPRA Custodian A. Battaglia admitted under oath and in writing she refused to provide a copy of any government record on the minor sub-division on Block 10902 Lots 10 and 12 to Mary Pawar, 12 East Drive, Stanhope, NJ or my wife or me and stated she would probably refuse a request for any government record on the minor sub-division, and whereas the Department of Human Services has refused for months to provide a copy of my own medical records and other documents I provided the CEO Mr. Main, the corrupt Dr. Joseph or the corrupt Dr Paul and whereas as admitted by the Probation officer Jenn Jobbagy on the court transcript she had NO authority to contact various doctors and refused to contact those that I did authorize the State of NJ to contract. Whereas in chambers your continued corruption and that of the Sussex County Prosecutor's First Assistant Prosecutor Gregg Mueller has apparently reached new heights he quit as my standby attorney.

3. Whereas your corrupt Vicinage Judge Bozonelis, AJSC issued a court order violating the Open Public Meeting Act, the Open Public Records Act and the constitutions of the United States of America and the State of NJ Constitution in that I can NOT examine any Govt record in the Borough of Stanhope nor can I attend Open Public Meetings at designated locations such as the Borough of Stanhope Land Use Board meetings or Open Public Town Counsel meetings, I hereby request a change in Venue as your Assignment Judge is a felon and as your conduct and the Sussex County Prosecutor's office in the form of its corrupt Prosecutor David Weaver and First Assistant Prosecutor Gregg Mueller have issued additional threats, whereas you have constantly violated the Code of Judicial Conduct.

4. Therefore I request a change in Venue in the Superior Court per R 4:3-3(c) as an Ex-Parte order.

A copy of this letter is being sent to U.S. Attorney Paul Fishman, USA and will be input to the criminal report tip line reporting system for the new Acting Attorney General of NJ Paula Dow.

6. In addition copies shall be forwarded to the FBI in Newark, the corrupt ACJC in Trenton and others.

7. If a discussion is required to complete this action I request it be in OPEN court and that I be called via telephone as all the fines on the 44 convictions by Judge Dana were vacated on Sep 10, 2009.
