1. This letter contains a request for court transcripts, request for transcript on a CD ROM of all hearings, conferences, trial before Trenton Municipal Court Judge Louis Sancinito, CJMC on a petty disorder charge by the corrupt State of New Jersey's Department of Community Affairs' Government Record Council's executive director used to obstruct justice, committed willful perjury and engaged in official repeated acts of official misconduct, had breach of duty, negligence and caused great emotional distress all violation exemptions of the Tort Claim Act. By the State's own exhibits S-1 and S-2 presented at the kangaroo court wherein due process was not conducted in accordance with the Rules of Ethics, wherein motions were ignored, two excess warrants were issued for my arrest the second one after 8 days of my being arrested in the Augusta State Police Barracks as Det Sgt Brown immediately recused himself when my wife Kathryn Caggiano and myself brought in only three feet of evidence. The total conspiracy is still unfolding as the Trenton Municipal Court has refused to provide court transcripts and refused to provide me copies of my own Affidavits of Probable Cause and court witnessed and prepared CDRs against Catherine Starghill, Esq., Judge Sancinito, and others.

2. I thank Judge Mitchel E. Ostrer, JSC for his efforts to prevent continued manifest injustice dated March 4, 2010 to assure that due process is served and our New Jersey and Constitutional Rights are protected and plead the court to take what court actions on its own motions after reading the full court transcript and ALL the defendant's exhibits including the State's own large exhibit S-2 which proves the complicity of many, a State felony, a conspiracy and efforts to support others commit criminal acts of perjury, illegal use of federal funds, state funds, county funds, and municipal funds known to dozens of agencies within the Federal Govt, State Government, County Government, and many municipalities in New Jersey as the newspapers have printed many stories of WE the PEOPLE pleading to simply comply with federal, state and municipal laws as the GRC with its chair Robin Berg Tabakin, its corrupt Department of Education member for the Commissioner of the Department of Education for years Kathryn Forsyth and others excluding the excellent former Chairman Vince Maltese, Esq who brought in a court reporter, left the GRC conference room and allowed the tyranny of a State Government Agency legislative embodied to provide transparency in Government to reduce the world known corruption in New Jersey as expressed by now ex-Gov Jon Corzine and his replacement Gov Christie whose prior position as U.S. Attorney of New Jersey was provided vast amount of evidence and notice of corruption and conspiracy by our Federal State Senator, Congressman, Office of Attorney General former Director of Consumer Affairs Kim Ricketts and myself and the State of New Jersey Gov, New Jersey Attorney General, Department of Consumer Affairs, Comptroller, Public Advocate, Department of Community Affairs which over 12,000 pages of evidence in its departments such as GRC, Codes and Standards, Local Government Services and Commissioners have been informed for years of the corruption in the Borough of Stanhope by not only myself but the excellent former Municipal Clerk Ms Robin Kline, RMC who I placed into the federal Government Whistle Blower Protection Program in Chicago, IL at the verbal direction of the Washington D.C. Office of Inspector General staff. Also the FBI Public Corruption Unit in Washington D.C. directed I contact the FBI offices which I did at Garret Mountain Plaza, West Paterson, and thereafter the Department of Justice's Office of Inspector General's New York City's Assistant Special Agent in Charge Cella filed my complaint to the FBI in Washington, D.C. Do to the GREAT public interest and injustice as dozens of persons have requested investigations as noted in the many attached letters inclosed. My mind set as displayed by the now eight years of one's public duty under the Declaration of Independence is to protect our citizens and their private property which I have attempted with my wife and neighbors and even State employees and municipal employees who were then attacked, fired, threatened repeatedly. Pa, U.S. Attorney General of the United States of America Eric Holder Jr. including NJ U.S. Attorney and FBI, Sussex County Superior Court under my now dismissed malicious indictment by the Sussex County Prosecutor David Weaver and other conspirators and confederates engaged in a repeated pattern of official misconduct, conspiracy and other State crimes noted in my many Affidavits of Probable Cause filed in Newton Municipal court, Trenton Municipal court, Newark Municipal court and the Joint Court of Green, Fredon, Hampton and Borough of Andover. All those affidavits and supporting documents and referenced exhibits are included by adoption into this VERIFIED CERTIFIED AFFIDAVIT Based upon my personal knowledge as shown it is relevant to one's mind set of property my neighbors who attempted in vain for years to have Justice and compliance with safety, health and environmental laws, construction codes, disbursements, contracts comply with laws and constitutions. The attacked documents are also provided to the Mercer County Prosecutor's Office per the direction of the Hon. Mitchel E. Ostrer, JSC.

3. My wife Kathryn and I have enclosed a check in the amount of \$500 from Inside on the Outside our partnership in its Case Study to expose tyranny in Government. I request the court direct the municipal court to provide a complete copy of the transcripts to all those agencies noted above including a complete copy of the transcript of all hearings, conferences, trial, et al on a CD ROM including myself so that I can make corrections in the transcript record and use it if needed to prepare a detailed brief in further support of my municipal appeal.

4. If there are any questions, as I and my wife are supporting the Department of Justice, the State Police Official Corruption Bureau and the U.S. P.S. Inspection Service as the Borough of Stanhope has defied Judge Conforti's court order of Sep 10, 2009 repeatedly which was filed on Nov 17, 2009. The dismissal of the criminal indictment filed Sep 10, 2009 is also included.
