Super. 392 (Law Div. 1975), and R. 4:43-2 Final Judgement by Default, your employee has by way of court transcripts I paid over \$4,000 and are filed with the Superior Court in my municipal appeals of all convictions by Judge Craig U. Dana, JMC under Municipal Appeals as I noted Ms. Jobbagy provided willfully a false impression to court of her knowledge and as agreed by the State of New Jersey represented by apparent authorized municipal prosecutor William Hinkes, Esq. a former law partner of the Sussex County Prosecutor David Weaver, she admitted on the court record she had NO authority to contact various doctors I voluntarily hired and admitted she did NOT contact any doctors and theraphists my wife and I attended do to the great emotional distress as I was illegally jailed as an inmate, illegally sentenced, illegally re-sentenced and illegally re-re-sentenced to serve 95 days in Keogh Dwyer Correctional Facility. Based upon my Pro Se municipal appeals and those prepared by my standby attorney Robert Mattia, Esq. the court in a finding on Sep 10, 2009 determined those facts were true and all fines were vacated, all probation was vacated by the court. The entire Probation Services files were entered as a Defendant's exhibit per the court transcript to prove she willfully had exculpatory knowledge not provided to the court in her defamation of my character and aided others in criminal conduct to have me illegally incarcerated by her conduct N.J.S.2C:5-1.c designed to aid another in commission of a crime of my false imprisonment N.J.S.2C:13-3, crime of omission N.J.S.2C:2-1, and false reports to law enforcement authorities N.J.S.28:28-4.b thereby obstructing administration of law N.J.S.29.1.a and tampering with witness and information to retaliate against me for having filed both quasi-criminal and criminal charges against her in sworn affidavits of probable causes for which the corrupt Superior Court Judge Thomas Manahan, P.J.S.C. violated court rules and also defamed by wife Kathryn Caggiano by under the Ind 08-09-316-I in State of New Jersey v.
