This record is for both my complaint for denial of access by the corrupt Borough of Stanhope for Government Records under My Complaints 2010-61 and 2010-67

The records requested by me in both Open Public Record Act requests submitted by me were per the OPRA law to the Borough of Stanhope OPRA Custodian Ellen Horak who was referred to the U.S.P.S. Inspection Service for mail tampering based upon the recommendation of the FBI Special Agent in Charge of the Las Vegas, Nv FBI Office as I was referred to that Department of Justice Office by the FBI Washington D.C. Unit Corruption Bureau. I and my wife Kathryn are witnesses to the State Police Official Corruption Bureau. This matter is also being brought to the attention of the N.J. Attorney General Paula Dow, the U.S. Attorney in Newark Mr. Fishman, the new Acting Special Agent in Charge for the FBI in Newark, NJ and others as this request for consideration with relevant material to justify reconsideration based upon my clear likelihood of success if undenial as the court orders cited by municipal judge Craig U. Dana, JMC are clearly unconstitutional and violate the Open Public Meeting Act. In addition, Judge Dana's court order violates the court order issued by Sussex County/Morris County Superior Court Judge B. Theodore Bozonelis, AJSC issued under Docket and also violated the court orders by Judge N. Peter Conforti, JSC based upon my municipal appeals of Judge Craig U. Dana's illegal court order that WAS VACATED by the State of New Jersey on Sep 9, 2010. In fact, the Sussex County Superior Court vacated ALL Judge Dana's fines, vacated all his probation, vacated ALL Judge Dana's court orders and issued its own court order that I had rights to obtain copies of Government Records as did the Assignment Judge Bozonelis, AJSC. Once again the felon Catherine Starghill, Esq. WITHOUT ANALYSIS, without the corrupt Case Manager notifying me of any such actions by the GRC which has received letters from me as well as its Acting Commissioner Lori Grifa, Esq. have by their action continued to support the criminal conduct of the Borough of Stanhope officials.

Since the court order by Judge Dana was VACATED by the Superior court and that is the only basis the corrupt State GRC lawyers stated which instead they have violated the Rules of Ethics R.1:14 in the Rules of Professional Conduct RPC 8.3 Reporting Professional Misconduct RPC 8.3b "A lawyer who knows that a judge has committed a violation of applicable rules of judicial conduct that raises a substantial question as to the judge's fitness for office shall inform the appropriate authority".

Whereas Catherine Starghill, Esq. has a cited conflict of interest in her malicious filing of a petty disorder charge and committed perjury in the Municipal Trenton Court her recusal for apparent conflict of interest remains as Superior Court Judge Ostrer has had to intercede in the Judicial process as the Trenton municipal court refused to provide the Superior Court and me copies of the court transcripts. My letter to the Hon. M. , the Mercer County Prosecutor's Office, U.S. Attorney, FBI, State of New Jersey's Office of Attorney General and the State Police's Official Corruption Bureau is adopted as a adopted referenced exhibit per the rules of NJ courts and also included is my motion to the Hon. M. to issue a Superior Court order directing Catherine Starghill, Esq. recusal. That motion is attached. As the case is already before the Superior Court Judge which concerning the corruption of Catherine Starghill, Esq and the GRC in supporting her and giving aide to others committing illegal acts. Whereas the GRC has also violated the OPMA by willfully NOT sending me copies of its agendas, per OPMA all such actions by the GRC should be voided per the OPMA as at least pertain to any actions by the GRC. Once again, WITHOUT ANALYSIS, false statements and obvious violations of the OPRA itself by Judge Dana's NOW vacated court orders since Sep 10, 2009 are OBVIOUS.

Whereas numerous Federal representatives, State representatives, more than a dozen property owners, and others list in my letter to the Hon. X and others is available on my filed web site with the Federal District Court of E.D. Pa., the Sussex County Superior Court which VACATED Judge Dana's illegal and unconstitutional court orders eight months ago as known to the State of New Jersey's executive branch and the Sussex County Prosecutor's Office. Also on Sep 10, 2009 the thirteen criminal charges against me by the GRC confederators in the Borough of Stanhope were ALL dismissed.

I have never been convicted of any criminal charge.

Judge Dana's court orders are obvious unconstitutional and obviously in violation of the Open Public Meeting Act which should be obvious to the corrupt executive director Catherine Starghill, Esq. as Judge Dana's court order is a felony itself N.J.S.2C:30-6(e) "for purposes of this section, an act is unlawful if it violates the Constitution of the United States of this State, or if it constitutes a criminal offense under the laws of this State.". Judge Dana's court order violates the freedom of free speech, the freedom of assembly, the freedom of presenting grievances as it does NOT even allow me to pay the State fees to have a Construction Code Official inspect my house on 10 East Drive, Stanhope, NJ for a Certificate of Habitation as my Real Estate agent was harassed for hours inside the Borough of Stanhope which even refused me to pay taxes in advance as I was moving to a NO income tax state. As stated by the corrupt Borough Attorney Richard Stein before Judge Bozonelis, I submitted eight hundred OPRA requests to the Borough of Stanhope which as the executive director Catherine Starghill, Esq is aware is false. Also Richard Stein false told Judge Dana, JMC the Borough submitted copies of ALL documents I requested which also the GRC knows if FALSE.

The GRC as an executive agent IS required to share information with the executive branch. The transcript records of the corrupt Borough of Stanhope Laddey, Clark and Ryan's statements are in the court transcript provided to the State's Sussex County Prosecutor.

Therefore, whereas Judge Dana's court orders were unconstitutional and in fact criminal acts, whereas Judge Dana's court order violates the Superior Court Order by Judge Bozonelis, JSC directing the Borough of Stanhope to comply with providing me copies of documents per OPRA, whereas Judge Conforti, JSC issued a court order directing the Borough of Stanhope to comply with such laws and whereas the OPRA itself can NOT be over ruled by a municipal judge who has NO authority to undermine the legislative intent of OPRA, and whereas the court orders referenced were vacated 8 months ago, and whereas perjury was also made by the Mayor of the Borough of Stanhope in the Judge Dana's court room, and whereas Ellen Horak was also a witness at the municipal court and was fully aware that Richard Stein committed perjury when he stated under oath that ALL documents I requested under OPRA were provided and whereas on the court record of Judge Solomon, ALJ the prior OPRA custodian admitted in writing and under oath that she willfully refused to provide myself, my wife and Mary Pawar a copy of ANY government record on the illegally developed minor Sub-division constructed by E.N.F. Development Co. LLC and as Ellen Horak also prepared altered minutes and as now Municipal Clerk of Stanhope has also violated the OPMA by NOT providing me copies of agendas of OPEN Public Meetings even have funds desposited, and whereas the newspapers have distributed to many thousands of persons in Sussex County newspaper reports, a public interest is obvious.

Whereas the Borough of Stanhope has funds deposited for providing copies of my deeds, property record cards, and has refused to even apply payments made to obtain copies of documents previously requested under OPRA for years, and whereas I can't sell my property at 10 East Drive or obtain needed records or file records irreparable harm has occurred as I was unable to close on a contract that was issued for the sale of my property and have suffered injury as well as my wife, neighbors and others.

I believe the above provides adequate reasons to reconsider the mistakes made by the GRC as they cite court orders that have NOT existed in 8 months and were issued in violation of OPRA and the Borough of Stanhope is aware such orders as the fines were repaid by the Borough of Stanhope by Judge Conforti's court order VACATING Judge Dana's court order on Sep 9, 2010.

I request that the GRC Catherine Starghill, Esq recuse herself for reasons filed with Superior Court Judge Ostrer on my municipal appeal No. 24-2009, Docket No. 18723. The my letter to the Hon. Mitchel E. Ostrer, JSC is a public record filed in Mercer County Superior Court and others and was published on FreedomNewsDigest.com and also ThomasCaggiano.com and is available at <http://thomascaggiano.com/100501ostrermovingpapers.pdf>. Also adopted into the VERIFIED CERTIFIED AFFIDAVIT is my complaint concerning the criminal conduct of Judge Dana which is available on and my complaint against the corrupt GRC executive director Catherine Starhill, Esq. as she has violated the Rules of Professional Conduct, the Rules of Ethics and request a copy of this request for reconsideration be forwarded to the Department of Community Affairs as an ETHIC complaint as she has violated the code of ethics for lawyers and has in fact assisted others for years in criminal conduct and committed perjury herself in Trenton's municipal court which has now been "ordered" by the Hon. Mitchel E. Ostrer, JSC to provide a copy of the court transcript which the Trenton Municipal court has refused to provide me. This transcript record on my court transcript requests sent via Judge Ostrer, JSC to the Trenton Municipal court has been requested to be sent to the U.S. Attorney, Mercer County Prosecutor, NJ Attorney General Paula Dow and FBI for a federal and state criminal investigation of the GRC Panel, excluding the former GRC Chairman Vince Maltese, Esq. and my prior Case Manager Dara Lownie. I placed the former OPRA custodian and Municipal Clerk Ms. Robin Kline, MAS into the Federal Whistle Blower Protection Program based upon directions I received from the Department of Justice's Office of Inspector General. When I explained in Judge Sancinito's municipal court that actions that GRC Catherine Starghill, Esq was engaged in his comment record on the court record was: " It's Insidious". Per the dictionary that word means: Working or spreading harmfully in a stealthy manner.

I therefore include by reference for reconsideration do to Mistake and Fraud the OPRA denial of access by the Borough of Stanhope in clear violation of OPRA and that a determination be made that ALL parties in the Borough of Stanhope that engaged in the fraud in Judge Dana's court, excluding the former excellent Borough of Stanhope Municipal Clerk and Sgt Zweigle ALL be included in these denial of access to include the Governing Body members Mike Depew and George Graham, Laddey, Clark and Ryan LLC and its lawyers and Borough Attorney Richard Stein, Esq. who committed perjury on the initial 18 Denial of Access in his false Statement of Information, his false reports to Judge Bozonelis, and his perjury in the Township of Green as these are court records available to the GRC in its review of WILLFUL determination of denial of ac-

cess. I also request ALL prior administrative closing without analysis by Catherine Starghill be ALL reconsidered as previously requested by me of the GRC as NO response has ever been made. I request compliance with OPMA and the GRC send me copies of its agenda to thomascaggiano@gmail.com and thomas_caggiano@yahoo.com at least 48 hours in advance.
