I have not heard from you in response to any of my many emails since we met in your office and I changed the proposed NJ Superior Court order that Sussex

County's corrupt Superior Court Judge N. Peter Conforti, JSC direction you to prepare when with the arrival of the new First Assistant Prosecutor Gregg Mueller, a honest person, my bail was immediately exonerated on his first day in office on Sep 1, 2009. Upon his motion, all criminal charges against me by the felons in the Borough of Stanhope were dismissed. This allowed me to leave New Jersey to live in our new home at 7086 Arcadia Glen Court, North Las Vegas, Nv 89084 a lovely community with neighbors who were prior citizens of the most corrupt State in America - New Jersey. These neighbors are very intelligent as they are board members on local community boards and complained to me immediately of vast corruption in their towns of Land Use Board and Construction Code Officials. What a shock as the Borough of Stanhope has been a den of conspirators, money launders, bribers for decades. ===== The data in now recorded on court transcripts in every corrupt court I was taken by felons and include Trenton Superior Court as no witnesses were allowed, no cross examination of affiants, my \$130 I paid for a cross complaint on the malicious filing by NJ AG, her corrupt Division of Law's Department of Community Affairs' Deputy Attorney General Debra Allen Esq. with its corrupt GRC executive director Catherine Starghill, Esq. and the corrupt In house lawyer Karyn Gorden, Esq. ===== I was banned by the corrupt Superior Court Judges from attending any Open Public Meeting at the State's corrupt Department of Community Affairs building except the corrupt Government Record Council which then kidnapped me for it own Open Public Meeting that had my complaints on its agenda against the Borough of Stanhope and the Office of Attorney General's corrupt Department of Consumer Affairs where other then my initial appearance at its corrupt Board of Engineers under complaint 05-13 against the incompetent and bribed John Cilo Jr. of John Cilo Jr. Associates who by fraud, trickery represented himself as the municipal engineer for Stanhope without any valid contract in decades. He was the pastie of the Planning Board and then the Land Use Board. He never even approved any as built drawing required for the certificate of occupancy to be issued on either house of the minor subdivision on Block 10902 Lots 10 and 12. There is NO 2 ft contour map of the minor subdivision even certified by the State of NJ and approved by the Board of Adjustment or the later Land Use Board as variance were needed and every property owner within 60 ft of the illegal development, as proven in my own successful third party appeal of the first to two fraudulent Soil Erosion and Sediment Control Plans both certified for only 1/2 the project on Block 10902 Lot 10 only by the former Mayor of Hopatcong, the corrupt Chairman of the Sussex County Soil Conservation District in Newton, NJ with corrupt members of the county on its Board of Supervisors who are on the Sussex County Planning Board where I also presented these false plans years ago in a Open Public Meeting as it lawyer attempted constantly from having me provide my greivances as allowed by things ignored in the Department of Justice's corrupt Newark U.S. Attorney's office and its corrupt FBI Special AGent in Charge Weysan Dun who even destroyed evidnce provided and did NOT appear in the corrupt Municipal court of Judge Louis Sancinito, CJMC where the corrupt GRC's executive director filed malicious petty disorder charges against me and without even sending in letters to quash my valid subpeano by Stanhope officials, not allowing witness as usual by

another corrupt Judge I was convicted. I appealed immediately and to the surprise of the court persons the record of my dates of the trial do not even exist in its records? I paid for the transcript which would prove perjury by Catherine Starghill, Esq. and that the judge convicted me based upon my age. Those records were NOT provided to the Mercer Superior Court who wrote me I had to get the transcript for those hearing to occur. I in fact visited their corrupt prosecutor who was even worse then the corrupt William Hinkes, ESq. of Newton, NJ who hired the corrupt Sussex County Prosecutor David Weaver, Esq. previously and slandered me constantly in the many so called trials in the corrupt Township of Green with the felon Laddey, Clark and Ryan's LLC's chief perjurer Richard A. Stein, ESq. Stanhope lead criminal of its Mayors, and Governing Body and Town Administrators. The former Town Administrator Teri Massood fled Stanhope without resigning whene my complaint GRC 2006-02 after a three year delay was sent after an eight month interim order was used to delay hearings. There as no hearing in the corrupt Office of Administrative Law by the felon executive judge J. Howard Solomon, ALJ in reality on 25 of the 28 items in the denial of access.===== The former Town administrator Teri Massood who was also part time treasurer approved the disbursement of federal funds, county funds and all funds to John Cilo Jr. Associates, Omland Engineering Associates, P. David Zimmerman a professional planner NONE who had contracts in 2006 or 2007. Since requests on contracts is to be immediate this would be immediately determined. So as my lawyer in my defense since per the corrupt Judge Dana's order I can not even submit an Open Public Record Act request to the cease pool Borough of Stanhope of which dozens have complained for years as noted on my web site now published from NV FreedomNewsDigest.com and formerly known ande as accessible as ThomasCaggiano.com which was filed in Sussex County Superior Court - Criminal Part as a Defendant's voluntary disclosure as a certified affidavit wht thousnds of referenced and adopted exhibits already in existance in the corrupt Office of the Gov of N.J. as some of these records are available in a .pdf file as my former POC Ian Brennan was removed from the Office of the Gov of NJ AFTER he requeusted an investigation of the Borough of Stanhope with the former Director of Consumer Affairs Kimberly Ricketts notified the corof rupt U.S. Attorney's Special Prosecution Branch Chief James Nobile who I met for two hours presenting a box of evidence including audio recording as the tapes are shown on my The CAG Report distributed in hard copy to many organizations and is available on any internet connection in the world that provides the complicity, confederation, conspiracy and criminal conduct of many dozens of corrupt Judges, prosecutors, Department of Justice, State, County and municipal officials and those they bribe. ===== Today, a moving van from our former home in NJ arrives at our new home in Arcadia Glen Court with 120 large boxes and 14,000 lbs of items as a ton must be evidence that has been in my house for years.===== That material represents only part of my Case Study evidence which shall be posted on the internet including audio recordings, etc===== As my lawyer on the municipal appeals and other hearing on the corrupt State Dr. from Anne Kline namely Dr. Joseph who I met while falsely imprisoned for 85 days of my 39 day sentence which the corrupt Judge

Dana changed in an illegal resentencing and then increased to 95 days in a second illegal resentencing. the corrupt judge signed a court requested document form that I requested a copy of the audio recording on a CD Rom of the so called hearing on probation violations by the reports of the corrupt Sussex County Probation Services Group which I also filed Affidavits of Probable Causes against in newton which disappeared after the corrupt newton municipal court judge Mulhern after recusing himself removed these affidavits illegally from its municipal court and his buddy, the corrupt Sussex County Superior Court Judge Conforti, JSC in his court orders on the now dismissed indictment through them all out without any hearing by any judge. The charges included criminal charges against the corrupt Sussex County Prosecutor David WEaver, Esq. and his corrupt Assistant prosecutor Josephy Corazza who oontinued that injustice of my indictment for thirteen criminal charges and a false filing by the Stanhope Corrupt Chief of Police Pittengher sp? and his patrolman.===== There is NO day in court?
